Arranged as showroom to front having false ceiling with inset lighting and carpet. To the rear a warehouse/production area with offices, store, kitchen, and cloakrooms has been created.

Roller shutter door to front plus personal access door. Further door at rear leading to fire escape corridor.

Front section 'L' shaped 6.2m (20' 3") \times 5.9 m (19' 3") plus 4.1m (13' 6") \times 1.3m (4' 3") – overall 41.9 sq m (447 sq ft) divided to form reception to one side with door to front and warehouse/workshop with roller shutter door to front Middle section 6.1m (20') \times 9.6m (31 6") – overall 58.6 sq m (1630 sq ft) Rear section 8.3m (27' 3") \times 10m (32' 9") – overall 83 sq m (892 sq ft) divided by false partitioning to provide for 3 rooms Total overall area 183.5 sq m (1969 sq ft).
